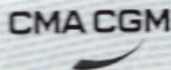

ADDITIONAL CLAUSES

274. The Merchant is responsible for returning any empty container, with interior clean, free of any dangerous goods placards, labels or markings, at the designated place, and within 60 days following to the date of release, failing which the container shall be construed as lost. The Merchant shall be liable to indemnify the Carrier for any loss or expense whatsoever arising out of the foregoing, including but not limited to liquidated damages equivalent to the sound market value - or the depreciated value due by the Carrier to a container lessor. The Carrier is entitled to collect a deposit from the Merchant at the time of release of the container which shall be remitted as security for payment of any sums due to the Carrier, in particular for payment of all detention and demurrage and/or container indemnity as referred above.

308. The Carrier is committed to comply with all applicable International and National Economic Sanctions such as, but not limited to, United Nations, European Union and U.S. legislations ("Sanctions") and their corresponding banned entities lists such as, but not limited to, the Special Designated National and Blocked Persons List (OFAC) the European Union List of Persons and Entities Subject to Financial Sanctions. By accepting this Bill of lading the Merchant agrees that irrespective of the final destination of the cargo, this shipment fully complies with the Sanctions and that any breach of the above terms shall prompt the immediate interruption of the carriage and Clause 10 Matters Affecting Performance shall

apply.

358. Following the exceptional measures adopted by various governments in relation with the outbreak of COVID-19 virus and the operational constraints resulting thereof, the Merchants are hereby notified that the carriage of cargo may be disrupted or delayed. Cargo may not be loaded on the intended vessel and may be on forwarded to the port of destination on any alternative vessel at Carrier's sole discretion. Furthermore in case of disruption of ports' operations, the cargo may be discharged in an alternative port without notice and - subject to availability - be on forwarded to the original intended port of destination. Carrier reserve its rights to accomplish the bill of lading in any alternative port. All additional costs, including but not limited to storage, demurrage, plugging, monitoring at the alternative discharge port or extra on forwarding costs, shall be on Merchant's account and payable before delivery and the carrier shall have no liability whatsoever for any loss or damage resulting thereof

366. The Merchant warrants that the particulars relating to the Goods have been checked and that such particulars are adequate and correct. In case of failure of the Merchant to comply with such warranty, the Carrier shall be entitled to charge the Merchant at any time an amount of USD 2,000 per Container or Goods (for non-containerized cargo) as processing and administrative fees. This fee shall also be

1. DEFINITIONS
In this Bill of Lading the terms:
Bill of Lading means the present document which contains the receipt for the goods and the contract of carriage.
Goods means the cargo and/or other articles received by the carrier in respect of which this Bill of Lading is issued.
Carrier means the person or persons who, in accordance with the contract of carriage, are responsible for the carriage of the goods.
Shipper means the person or persons who, in accordance with the contract of carriage, are responsible for the shipment of the goods.
Receiver means the person or persons to whom the goods are to be delivered.
Port of Loading means the port or place at which the goods are loaded on board the vessel.
Port of Discharge means the port or place at which the goods are discharged from the vessel.
Place of Receipt means the port or place at which the carrier receives the goods.
Freight means the remuneration payable by the shipper to the carrier for the carriage of the goods.
Tare means the weight or measurement of the container or packaging in which the goods are carried.
Measurement means the quantity of the goods as stated by the shipper.
Gross Weight means the weight of the goods including the weight of the container or packaging.
Net Weight means the weight of the goods excluding the weight of the container or packaging.
Volume means the quantity of the goods measured in cubic meters or other units.
Number of Original Bills of Lading means the number of original bills of lading issued for the goods.
Final Place of Delivery means the port or place at which the goods are to be delivered.
Description of Packages and Goods means the description of the packages and goods as stated by the shipper.
Marks and Nos. Container and Seals means the marks and numbers of the container and seals.
No. and Kind of Packages means the number and kind of packages.
Shipper's Load, Stow and Count means the shipper's responsibility for the loading, stowage and counting of the goods.
Said to Contain means the shipper's declaration of the contents of the container or packaging.
Gross Weight Cargo means the weight of the goods including the weight of the container or packaging.
Tare means the weight or measurement of the container or packaging in which the goods are carried.
Measurement means the quantity of the goods as stated by the shipper.
