GENERAL TERMS AND CONDITIONS

1. Application

These Terms and Conditions shall apply to all shipping services performed by Punto System Spa (hereinafter 'PS'), except as expressly waived in the Order Confirmation sent to the Customer upon acceptance of the assignment of shipment.

2. Engagement Subject

The assignment has as its object the shipping services covered by Articles 1737-1740 of the Italian Civil Code. PS claims to be enrolled in the Freight Forwarders Register at Modena Chamber of Commerce number MO030005.

2. (Continued) Customs formalities

For the accomplishment of customs formalities, if required by the customer, PS will use customs agents and / or Customs service centers of their trust. The Customer undertakes to provide to PS all information and documentation necessary for the implementation of the customs declaration, including those relating to the origin, classification and value of goods shipped.

3. PS Responsibility

PS undertakes the obligations and responsibilities of the shipping contract, as provided for by art . 1739 of the Italian Civil Code. In no case, however, PS will be liable to Customer and / or third parties for amounts which exceed the limits of liability enforceable by the carriers responsible for the execution of the transport, or part of it, during which the loss or the damage occurred . It is also excluded the recoverability of indirect damages.

4. Terms

PS will ensure that carriers involved will carry out the transport in accordance with the delivery terms requested by the Client, but cannot be held liable for any delays not due to its direct fault.

The delivery terms will in any case be considered as indicative .

5. Insurance

Where expressly request and upon payment of the premium, PS can arrange the insurance on Customer's behalf to cover the value of the goods. The customer in this case will examine the conditions regarding insurance undertaking not to raise complaint against PS for any damage not covered by the insurance policy of the goods.

6. Payment

The terms and conditions of payment are regulated in the Order Confirmation. In case of late or non-payment, the Customer recognizes to PS the right of retention on goods also different from those in which the delayed / non-payment has occurred.

7. Complaints

Claims must be made in writing and within the time limits set by Italian law or by uniform right applicable to the contract of carriage performed by the carrier, including those relating to limitation, revocation and / or disclosure of reserves. In no case the complaint may result in the suspension of the payment of services rendered for shipments other than that for which the claim is made.

8. Governing Law and Jurisdiction

Any dispute arising from or occasioned by this contract is governed by Italian law and to the jurisdiction of the Court of Modena with the exclusion of any other court .
